Terms and Conditions of 2017 Miele® EcoFlex Dishwasher Tabs/QuickIntenseWash Promotion. (1) This promotional offer (the “Voucher”) from Miele, Inc., a Delaware corporation (“Miele”), provides a complimentary year’s worth of dish tabs (retail value \$150.00) (the “Tabs”), when you purchase any Miele® Crystal or higher-quality dishwasher model, i.e., G4720 SCi, G4780 SCVi, G6625 U CLST, G6625 SCU CLST, G6665 SCVi, G6665 SCVi SF, G6745 SCU Black, G6745 SCU White, G6745 SCU CLST, G6785 SCVi, G6785 SCVi SF, G6835 SCi CLST, G6880 SCVi K2O, G6875 SCVi, G6875 SCVi SF, G6885 SCVi K2O, G6935 SCi CLST or G6987 SCVi K2O (each, an “Eligible Appliance”). (2) After purchase of the Eligible Appliance, twenty (20) of the Tabs and a Voucher redeemable for the other two-hundred eighty (280) Tabs will be shipped to the customer with or inside the Eligible Appliance by or on behalf of Miele. (3) The Voucher only applies to the advertised price of the Eligible Appliance and shall not apply to any taxes (including sales tax), shipping charges or any other out-of-pocket expenses. (4) Only end users may benefit from the Voucher. The Voucher shall not apply to wholesale buyers or any person or legal entity who offers for resale, or resells, the Eligible Appliance; when used, or attempted to be used, in connection with such transaction, the Voucher shall automatically be void. (5) The Voucher shall be valid only in-store at participating authorized Miele dealers and online through participating authorized Miele dealers’ websites. To receive and qualify for the Voucher, the retail end user shall submit an online Voucher claim and copies of all of the required supporting documents (i.e., a valid order invoice and valid proof of payment). (7) All Voucher claims shall be submitted online at <http://mielestore.com/promos/freetabs> on or before December 31, 2017; please allow 6-8 weeks from submission for processing and shipment of the Tabs. (8) To qualify for the Voucher, the Eligible Appliances must be (a) ordered in person at the store of an authorized Miele dealer or (b) purchased online through an authorized Miele dealer during the Voucher period of April 1, 2017 through and including September 30, 2017 (the “Redemption Period”). (9) Purchases made on or before April 1, 2017 shall not qualify for the Voucher. Purchases made on or before April 1, 2017, and subsequently can-celled and reissued during the Redemption Period shall not qualify for the Voucher. Purchases made during the Voucher Period and subsequently cancelled and reissued after the Voucher Period shall not qualify for the Voucher. (10) In the event that any of the Eligible Appliances are returned to Miele or a Miele dealer after any of the Tabs have been delivered, the Voucher and/or Tabs shall be forfeited and must be refunded to Miele in their entirety at the purchaser’s expense together with shipping charges and a charge of \$150 for the Tabs. (11) The purchaser shall be eighteen (18) years or older. (12) Phone orders shall not qualify for the Voucher. (13) The Voucher shall be voidable at any time at Miele’s discretion if the retail end user shall not produce a valid order invoice and valid proof of payment; or if the retail end user shall otherwise violate the applicable rules. (14) No substitutions shall be allowed. (15) The Voucher is only available to residents of the fifty (50) states of the United States of America and the District of Columbia. The Voucher is not valid for residents of Puerto Rico, the U.S. Virgin Islands and any other territories or possessions of the United States of America. (16) Any misrepresentation by the person placing the order, whether in-nocent or fraudulent, shall disqualify him or her from the Voucher and further rebates offered by Miele; Miele reserves its right to refer such person for civil and/or criminal prosecution. (17) In no event shall Miele be liable for more than the value of the Voucher. (18) Miele may amend or discontinue the Voucher at any time with or without notice, including after an order is placed. (19) The above terms and conditions are severable and, if one or more provisions shall not be valid under applicable law, the remainder shall be enforceable to the maximum extent permitted by applicable law.
